3. Establish a Quorum:

Self-introductions were made and a quorum was established with 14 voting members present, including 1 utility member and 1 contractor.

4. Approval of Minutes from Last Meeting:

Minutes of the May 19, 2016 meeting were unanimously approved; motion to approve by Dan Peterson; seconded by David Mitchell. Minutes of the June 16, 2016 meeting were unanimously approved; motion to approve by Dan Peterson; seconded by Chris Kubasek.

5. Correspondence:

- Mike Tatalovich reminded the committee members that the Operating Policies and Procedures revised the names of the Surface and Underground Subcommittees to remove the word “New” from their name, and that subcommittee correspondences should reflect this change.
- Proxy – Rob Huning for Edward Errington, City of LA, dated July 21, 2016.
- Email dated July 16 from Curt Gilley to GB Committee members forwarding an email response from the City of LA (Raffi Massabki) that the City of LA has no objections to updating the ASTM Standard D1897 to D3641 “Standard Practice for Injection Molding Test Specimens of Thermoplastic Molding and Extrusion Materials” for Section 207-15.3 (Pickle Jar Test).
- Email dated June 22 from Mark Moeller with with Advanced Drainage Systems, Inc. (ADS) to Erik Updyke to apologize for an ADS staff member stating that ADS polypropylene pipe is “approved” by the Greenbook. The same day, via email, Erik requested ADS send a formal letter retracting the statement in question, signed by an ADS corporate official.

- a. Co-Chairman’s Report:
Erik Updyke reported:
 - 1) APWA Annual Greenbook Seminar is scheduled for Nov 10, 2016 at the Carson Civic Center.
 - 2) Erik discussed the email correspondence listed above dated June 22, 2016 in which a vendor stated that their pipe is “approved” by the Greenbook.

- f. Surface Materials and Methods Subcommittee Report:
Chris Kubasek reported:
 - 1) Work on Changes 246S, 267S, 270S, and 272S continues. 246S is anticipated to be sent to editorial this month, followed by 267S next month.
 - 2) Erik recommended that the subcommittee assign change number 279S to the microsurfacing specification work, which is being added to the Specifications Section 302-3 by the Asphalt Task Force. Micro-

Surfacing is a polymer modified, asphalt emulsion based, dense graded, cold mixed, quick setting, asphalt resurfacing material. It is designed to be applied in a semi-liquid condition with a specialized mixing and paving machine. By design it chemically changes from a semi-liquid material to a dense cold mix material that is able to carry normal traffic within one hour after application.

d. Underground Materials and Methods Subcommittee Report:

Curt Gilley reported:

- 1) Change 278U is scheduled for the August agenda.
- 2) Section 217 went to Editorial, Editorial returned the section with edits, which are being reviewed and incorporated.
- 3) Development of RC box specifications continues.
- 4) The ASTM standard in Section 207-15.3 (Pickle Jar Test) was updated to D3641. The City of LA has approved the change, which will be sent to Editorial.
- 5) Work on Part 5 and Section 307 continues.

h. Standard Plans Subcommittee Report:

- 1) The July meeting was cancelled.
- 2) The Subcommittee continues to define the approach and extent of work. Tasks are formed working off of comments, and sub-subcommittees are forming to address detailed tasks.
