 - A. Change No. 176NS Pervious Concrete –

Change No. 176NS is <u>still</u> with the Editorial Subcommittee for review however Jerry believes it may be out soon.

Changes to the coarse aggregates should be available for discussion in the near future, with more discussion necessary on the fine aggregates. The Task Force chair is requesting a "heavy" industry and agency attendance at the January meeting for the review and discussion of fine aggregate. A discussion regarding Section 201-1.3.2, combined grading limits centered on the inclusion of the word "shall vs. may" referring to the waiving of individual gradings. The Group recalled the use of the word "may" since the inception of the Section in 1992.

Introduced to the Subcommittee last month, and is currently on the 30-day hold for review.

D. Grout Section 202 Modifications -

The latest revision sent out with last month's minutes was accepted as "complete" with the minor change to Note 6 and a request to perform a Metric Conversion review.
