1. Minutes from the previous meeting:
 - a) Minutes from the June 2020 meeting were reviewed by all
 - b) A motion was made by Jeff Pollard to approve the minutes
 - c) Motion passed without objection

2. Current Business:
 - a) Change No. 246 SM: ASR Testing
 - i. Issue w. previously-proposed language – reason for revisiting
 - ii. Standards have been updated since this change was worked on – requires updating
 - iii. Expertise in this area was not on the call – item was held for next meeting
 - b) Change No. 286 SM: Special Exposure Mixes (201-1.1.3)
 - i. Reviewed proposed change language
 - ii. Will have another reading in August meeting and be balloted in September
 - c) Change No, 304 SM: Section 201-1 Reorganization
 - i. Discussion began with section 201-1.2.8 ‘Reclaimed Concrete Material’
 - a. Better definitions are needed – group will look at the recent Caltrans report on this issue at next meeting
 - ii. Sec. 1.3.4 – group had previously discussed minimum cement content in ‘Compressive Strength’ mixes, suggestion was made to remove the requirement for mixes that already require trial batches and minimum compressive strengths
 - iii. The group will continue to review the draft reorganization in future meetings, next up will be 201-1.3.6 Pervious Concrete

3. New Business: Jeff Pollard, on last month’s topic of Greenbook electronic availability, noted that workzone.com has the hard copy of the Greenbook available for \$100, and hard copy + electronic access for \$200.
