  - A. **Stabilized Base Task Force** (K. Nadaraja) Task Force met on 9/1/16 to continue working on revisions to the proposed Engineered Emulsion Stabilized Pulverized Base. It should take approximately four months to complete the revision work (April 2017). The next Task Force meeting is 11/1/16.
  - B. **Asphalt Task Force** (B. Thomann for T Williams) Change 267NS (Asphalt Emulsion) is essentially complete with the exception of a few minor changes. Change 267NS will be submitted for final approval subject to publication of a supplemental. Discussed "SuperPave for Local Agencies" and the concept of a round robin sample testing by various laboratories to correlate the number of gyrations to provide 4% asphalt content by weight.

- C. **Concrete Ad Hoc** (D Long) Change 246 NS Alkali Silica Reactive (ASR) aggregate has minor changes. Change 270NS (Expansive Cement) transferred to Underground Subcommittee. Requesting Change Numbers for two items under discussion Class N Pozzolans (201-1.2.5.4) and permeable material (200-1).
