5. Task Force Chairs provided updates:
 - A. **Stabilized Base Task Force** (Vinh Tran) V. Tran provided an update on the February 6 meeting. The meeting was lightly attended and members continued to review comments on the Engineered Emulsion Stabilized Pulverized Base specification.
 - B. **Asphalt Task Force** (Tom Williams) T. Williams provided update on February 7 meeting. The members discussed the results of the second round of AC samples ("B" gradation) for the Superpave AC for local agencies. Task Force continues evaluating Section 203-5 SLURRY SEAL to relocate certain specifications better suited in Section 302-4 SLURRY SEAL SURFACING.

- C. **Concrete Ad Hoc** (Durand Long) D. Long provided update on January 11 meeting. Task Force revised and will resubmit to the Surface Subcommittee Change 285 S Permeable Materials, and Change 286 S Type N Pozzolans for approval. Task Force continues working on an outline for reorganization of Section 201-1 and realizes this may be a larger task than first anticipated. Task Force looking into adding a table of temperatures to Section 300. The next meeting will be in Caltrans' Southern Regional Laboratory in Fontana.

 - A. **272 NS Stone for RipRap**: Task force agrees to use Caltrans requirements for acceptance of rock. Members are discussing field approval requirements such as percentage wear.
 - B. **286 S Special Exposure Requirements (Class N Pozzalon)**: In general, the Task Force continues to review the special exposure issue.
 - C. **287 SP Engineered Emulsion Stabilized Pulverized Base**: Proposed change is still under review.
