"Test specimens shall be conditioned in a mechanical convection oven for 7 days and to obtain a constant weight at a temperature of $\underline{110^{\circ} \, F} \pm \underline{5^{\circ} \, F}$ (43° C \pm 3° C) (110° F \pm 3° F) and subsequently cooled for 3 hours in a desiccator."
