- A. CG will look into a replacement for RK to perform the duties of Secretary of the NM & M – Underground Subcommittee.

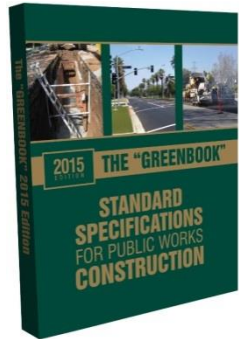
